## <u>1 DRAFT MASTER PLAN PROPOSAL - PROCTOR PARK FOOTBALL PRECINCT</u> (04.00044)

## **Recommendation**: That Council:

- (a) endorse the Draft Master Plan proposal for the development of the Proctor Park Football (Soccer) precinct, Bathurst and;
- (b) commence with the consultation process with all relevant stakeholders in order to finalise the Draft Master Plan and prepare a final report for Council's endorsement.

**<u>Report</u>**: Proctor Park is the recognised precinct for football (soccer) in Bathurst. Together with the adjacent multi use fields of Police Paddock, the Proctor Park Football Precinct is used heavily during the football season which runs from the start of April to the end of September each year.

The Proctor Park Precinct is Bathurst's only soccer facility which is administered under the banner of the Bathurst District Football Association Inc. The Precinct is utilised by numerous clubs for various competition events, including local fixtures and a number of regional competition fixtures such as the NSW Women's Super League and the Men's State League, as well as regular use by various schools for specific competitions throughout the season. In addition there are a number of major pre-season carnivals held at the Proctor Park complex which required the use of all fields as early as February each year.

Although Council has provided various improvements to the Proctor Park Precinct over the past 10 years, it is believed that due to the continuing growth of football in Bathurst and the high level of usage demand being placed on the facility, significant major upgrades and improvements will need to be considered within the near future to support the ongoing demands and future usage requirements for this sport.

In 2008, in conjunction with the various local football clubs, Council commenced investigations towards the future development of the Proctor Park/Police Paddock precinct as a central football (Soccer) complex for Bathurst.

Following various discussions over the years with various football stakeholders, a draft Master Plan of the Proctor Park Precinct has been developed as a basis to further develop the facility into the future, to enable the Precinct to meet the growing demands for football.

The draft Master Plan Proposal shown as <u>attachment 1</u> displays the proposed future layout and direction of the Proctor Park Football Precinct, which highlights the inclusions and additions that is believed would be necessary to support the future increased usage demands for football within the Bathurst Region. It is proposed to present the Master Plan in draft form to all stakeholders to ensure that the proposals and priorities meet overall expectations from the users of this Football Precinct and that there is an agreed consensus on the proposed future directions to this facility. Upon completion of the stakeholder consultation process, a final report will be submitted to Council for adoption and ultimate implementation, as resources become available.

**<u>Financial Implications</u>**: The works involved within the consultation process are covered under existing staff resources.
