1 BINC (KEPPEL STREET) CAR PARK (22.00010)

Recommendation: That Council approve the additional expenditure in relation to the BINC Car Park as outlined in the report.

Report: Council allocated \$220,000 for the construction of the BINC Car Park in the 2015-16 Operating Plan. The original costing submitted to the operating plan covered only a standard car park construction using the existing car park lay out.

Council's Staff have, however, identified that by redesigning the car park approximately 51 additional car spaces could be attained (approximately 35 spaces by sealing a previously unsealed section of the carpark and a further 16 by reconfiguring the existing car park layout). Staff have also identified that additional improvements could be incorporated into the car park design including improved storm water management, the inclusion of rain gardens and foot paths as well as the provision of waste bins and cigarette butt bins to reduce the incidence of litter in the area. A revised design for the car park was prepared which incorporated the additional car parking spaces and other improvements. The revised car park design can be found at attachment and a location plan can be found at attachment 2.

The cost of these enhancements to the car park design is estimated at an additional \$89,000 more than the original budget of \$220,000. The additional funds can be sourced from existing allocations, with \$45,000 proposed to be sourced from Integrated Water Cycle Management Plan (IWCM) funds and \$44,000 proposed to be sourced from Section 94 car park funds. It is appropriate to source the funds from these allocations as the improved storm water management of the revised design is consistent with the objectives of the IWCM and the additional car parking spaces achieved allow the use of Section 94 funds.

<u>Financial Implications</u>: That Council approve the construction of the BINC Car Park at a cost of \$309,00 with additional funds to be sourced from the IWCM (\$45,000) and Section 94 Car Parks (\$44,000) budgets. All funds are to be sourced from existing allocations.
