Bathurst Family Day Care (FDC) has provided a quality Early Childhood Education and care service to the Bathurst Community for over 30 years.

FDC currently have Educators offering professional education and care within their own home in the Bathurst, Lithgow and Oberon areas. Children are provided with an educational program that is play based and reflective of each individual child's interests, needs, strengths and capabilities.

We offer standard and non-standard hours of care including overnight, weekend, before and after school and emergency care for children aged 0-12 years.

#### Our Philosophy

Our aspiration is to acknowledge the exceptionalism and potential of all children, by supporting them in their growth to become successful, confident, and socially competent members of their community who positively embrace inclusion in all its forms.

## BECOMING AN EDUCATOR

Being a Family Day Care Educator offers a fantastic career opportunity working with children and allowing you to run your own business from home.

Becoming a Family Day Care Educator takes time and commitment. Family Day Care Educators are dedicated reliable and willing to learn new skills and take on new challenges. You will need to be able to adapt to different people, work collaboratively and most importantly be motivated and committed to working with children.

You will need to be over the age of 18 years and obtain a current HLTAID012 First Aid and CPR qualification, a Working with Children Check, a National Criminal Check, a medical clearance, public liability insurance and hold a minimum of Cert III in Children's Services.

Suitable applicants will be invited for an interview at the Family Day Care Service. An assessment of your home as a suitable care environment will be conducted.

#### Your Responsibilities as an Educator

- Understand your obligations to abide with National Regulations, Law and service policies and procedures
- · Provide a safe, clean learning environment including resources and equipment
- Plan and provide play-based learning experiences for all children in care
- Demonstrate the ability to respond to children in an appropriate manner with a positive approach to behaviour management
- · Maintain accurate records and always maintain confidentiality
- Promote open communication with families to build trusting partnerships

#### Professionalism

You will be required to promote yourself and your business in a professional manner. This will be reflected in ways you present yourself, your business and in the community. This professional attitude aligns with the Family Day Care philosophy to provide exceptional care and education for all children, ensuring the best possible learning environment is provided.

# OPERATING A FDC BUSINESS

#### Hours of Operation

Family Day Care Educators are self-employed, which means you set your own hours of operation. We recommend operating for at least 8 hours per day and consider the needs of the families and community.

#### Fees and Charges

Educators set their own hourly fees based on their qualifications, experience, environments, and other services provided. Ensure your rates are competitive and accessible to families.

Educator Levy	\$1.80
Harmony Web Fee	\$6.00
Family New Enrolment Fee	\$44
Parent Administration Levy	\$1.80 per hour

#### Centralised Gap Fee

Families who receive a Child Care Subsidy must make a co-contribution to their education and care fees. This is known as the Centralised Gap Fee. Under the Family Assistance Law, families are required to pay the gap fees using an Electronic Funds Transfer (EFT) method. Bathurst Regional Council Family Day will manage all parent accounts through Harmony Web, the software program used by Educators and Administration to manage business processes. All Invoices will be sent out in arrears. Educators will not receive the gap fee until parents have paid Bathurst Regional Council.

### Promotion of your Service

You can use various tools to promote your service such as flyers, brochures or social media. The service will work alongside you to market your business in the community. CDO's will support you in the promotion of your service.

#### Ratios

Your Family Day Care Service will adhere to strict ratios. Please see ratio requirements below:

- 1 Educator to seven children, maximum of four children preschool age or under
- Ratio includes the Educator's own children younger than 13 years of age if there is no other adult to care for them.

## Childcare Development Officers (CDO)'s)

Bathurst Family Day Care has two CDO's, operating in the FDC office from Monday to Thursday. Their role is to offer support to Family Day Care Educators, via facilitating enrolments and providing administrative assistance. CDO's are available to receive feedback from Educator's and provide professional development and guidance when needed.
